# **PRODUCT DESCRIPTION**

TM4130 is cross-linked polyethylene foam coated on one side with 2.2mils of skin friendly medical grade acrylic adhesive. The adhesive is protected by a 96# white polycoated Kraft release liner.

TM4130 is designed for mounting electro-medical devices to human skin. Typical applications include electrocardiograph pads, grounding pads, automatic external defibrillator pads, I.V. securement and other applications requiring skin contact.

## PRODUCT CONSTRUCTION

**Carrier**: 1/32" Medical Grade Polyethylene Foam

**Adhesive**: This medical grade acrylic adhesive has been formulated for sustained contact with human

skin. It has been assessed by an independent bio-medical laboratory following ISO-10993 guidelines for skin contact properties. Specific test procedures and results are available

upon request.

**Liner**: 96# bleached polycoated Kraft release liner.
